WILD ANIMALS AND BIRDS ACT

(CHAPTER 351, SECTION 3)

WILD ANIMALS AND BIRDS (BIRD SANCTUARIES) ORDER

[31st July 1970]

Citation.

1. This Order may be cited as the Wild Animals and Birds (Bird Sanctuaries) Order.

Prohibition on killing or taking.

2. The killing or taking of any bird in any of the areas described in the Schedule is prohibited.

Prohibition on netting, snaring or taking.

3. The netting, snaring or taking by any means of contrivance of any bird in any of the areas described in the Schedule is prohibited.

THE SCHEDULE

(a) All that piece of land comprised in Lot 97 of Mukim No. 11 in the District of Tanglin in the Republic of Singapore known as the Botanic Gardens of Singapore containing an area of approximately 326,530.7 square metres the boundaries of which are more particularly delineated and edged in a neutral tint on Certified Plan No. 10226 filed in the office of the Chief Surveyor, Singapore.

(b)

(i) All that piece of land situate in Town Sub-Division No. 25 Tanglin Mukim, in the Republic of Singapore, forming part of the National University of Singapore Grounds comprised in Lot 104 and estimated to contain an area of 357,135.1 square metres.

(ii) All that piece of land situate in Town Sub-Division 25 Tanglin Mukim, in the Republic of Singapore, forming part of the National University of Singapore Grounds comprised in Lot 103-8 and estimated to contain an area of 16,402.0 square metres.

(c)

(i) All that piece of land situate in Mukim XVI, Bukit Timah in the Republic of Singapore known as Bukit Timah Forest Reserve comprised in Lot 74-2 and estimated to contain an area of 662,925.7 square metres, the boundaries of which are more particularly delineated and edged green on Certified Plan No. 8564 filed in the office of the Chief Surveyor, Singapore.

(ii) All that piece of land situate in Mukim No. XVI, Bukit Timah in the Republic of Singapore lying on the South-east of Bukit Timah Forest Reserve comprised in part of Lot 81-4 (State Land) and estimated to contain an area of approximately 86,248.6 square metres, the boundaries of which are more particularly delineated and edged green on Certified Plan No. 7497 filed in the office of the Chief Surveyor, Singapore.

(d) All that piece of land situate in Town Sub-Division No. 20 in the Republic of Singapore known as Fort Canning Park comprised in Lot 148-3 and estimated to contain an area of 57,819.5 square metres, the boundaries of which are more particularly delineated on Certified Plan No. 8299 filed in the office of the Chief Surveyor, Singapore.

(e) All that area comprised in parts of Lots 21-9 and 97 (State Lands) and that part of Stamford Canal within Lot 21-9, Town Sub-Division No. 19 containing an area of approximately 404,685.6 square metres and known as the Istana Grounds.

(f) All the parcels of land referred to as the Public Utilities Board, Catchment Area in the Republic of Singapore, and mentioned below, and more clearly defined in Drawing No. W.E. 2872/35 as filed in the Public Utilities Board, Water Department Drawing Office.
