Application and payment can be made by mail. Fee for a **sterilised dog is \$14 and \$70 for an unsterilised dog**. Cheques are to be crossed and made payable to **AVA or Agri-Food & Veterinary Authority**.

### NOTES TO APPLICANTS

- A. A maximum of 3 dogs may be kept in a private premises. Prior written permission of the Director-General, Agri-Food & Veterinary Services must be obtained to keep more than 3 dogs.
- B. Contravention or failure to comply with any of the following requirements is also an offence under the Animals and Birds (Dog Licensing and Control) Rules and can result in the impoundment of the dog, a fine of up to \$5000, and/or revocation of the dog licence:
  1. All dogs above 3 months of age must be licensed.
  2. The dog must be implanted with a microchip.
  3. The dog must be on a leash in a public place.
  4. The dog should not be allowed to stray.
  5. A dog of a breed classified as dangerous or potentially dangerous or fierce must be muzzled when in a public place. (Please see schedule I & II breeds below)
- C. Impoundment fees, caring and feeding costs will be imposed for the recovery of an impounded dog.
- D. A dog licence is valid for one year only and must be renewed before expiry of licence. The renewal fee for a sterilised dog is \$14 and \$70 for an unsterilised dog.
- E. Failure to comply with the dog licensing conditions can result in the revocation of the dog licence and impoundment of the dog. Additional licensing conditions may be imposed and existing licensing conditions may be subject to change by AVA at any time.

### Scheduled Breeds

- **Schedule I** : Pit Bull (Americal Pit Bull Terrier or Americal Pit Bull or Pit Bull Terrier, American Staffordshire Terrier, Staffordshire Bull Terrier, American Bull dog), Akita, Neapolitan Mastiff, Tosa, Dogo Argentino, Fila Brasileiro, Boerboel and their crosses.
- **Schedule II**: Bull Terrier, Doberman Pinscher, Rottweiler, German Shepherd (Belgian Shepherd, East European Shepherd), Mastiffs ( Bull Mastiff, Perro De Presa Canario, Cane Corso, Dogue De Bordeaux) and their crosses.
