DISPOSAL OF REJECTED CONSIGNMENTS

We wish to remind all importers that any meat product, fish product, egg product, fresh fruits and vegetables and plant and plant products which has been inspected and found to be unfit for human consumption or not allowed for import is to be destroyed or disposed of as prescribed by AVA.

Traders are required to follow the following procedure for destruction or return of the rejected consignments and submit the relevant documents to AVA:

- (a) Trader to segregate the rejected goods and isolate them in a designated area for sealing by AVA within one week;
- (b) Trader is to make arrangement with AVA inspector for supervision on stuffing and the appointed escort agencies for escort of the rejected goods to the incinerator plant or port of export;
- (c) The rejected goods are to be destroyed or returned to country of origin within the stipulated deadline;
- (d) Trader is to submit supporting documents (NEA destruction certificate or export permit and bill of lading) to AVA within 3 days after day of destruction or return of rejected consignment;
